

WELCOME TO OUR KITA

STATEMENT OF CONSENT

for the use of personal images, personal data and individuals' works for the online presentation of the Kita _____ / of the provider _____ of the Kita _____ and for selected print media

Personal images in this sense are photos, graphics, drawings or video recordings, which depict children in an individually identifiable manner.

In appropriate cases, we should like to make information about events in the life of our Kita open to a wider public. We therefore intend from time to time, especially in the context of educational work or Kita events, to publish any resulting works and photos.

Consent is voluntary.

A refusal to provide consent or the withdrawal of consent shall not have any negative consequences.

I/we have received the following information (regarding data protection law):

- › The rights to the photos are granted at no charge and equally include processing rights, provided such processing does not cause any distortion. Audio and video recording and filming are not included under this consent.
- › Nor are other print media, which are produced together with the Kita and/or the provider nationally or by other providers, covered by this consent. Consent for the use for such purposes of selected photo databases may only be obtained „specifically for the occasion in question“.
- › I/we may withdraw this consent at any time in writing.
- › For printed matter, consent may no longer be withdrawn once the print order has been placed.
- › Unless consent is withdrawn, it is considered to be of indefinite duration, i.e. for the entire Kita year and in principle - unless otherwise specified - beyond the period of attendance at the Kita also.
- › Once published online, the images of my/our child may be transmitted and downloaded worldwide. The data may therefore also possibly be located by so-called „search engines“. The possibility of other individuals or businesses linking the data to other personal data available online, i.e. profiling, modifying the data or using it for other purposes cannot therefore be ruled out. I/we may withdraw the consent to publication online at any time by writing to the Kita management.
- › Not only newspapers, but also the other print media referred to below, may possibly also be viewed online and downloaded. Information and images published online may be accessed worldwide and anyone can download and store them, and combine them with other data. Once information has been published online, it can practically no longer be removed.
- › There is likewise no entitlement to publish/use an image on which my/our child is depicted with others.
